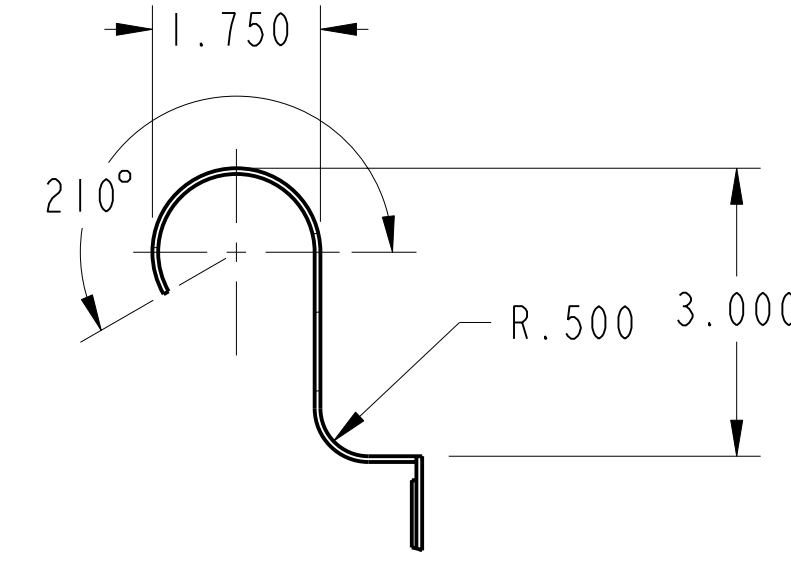
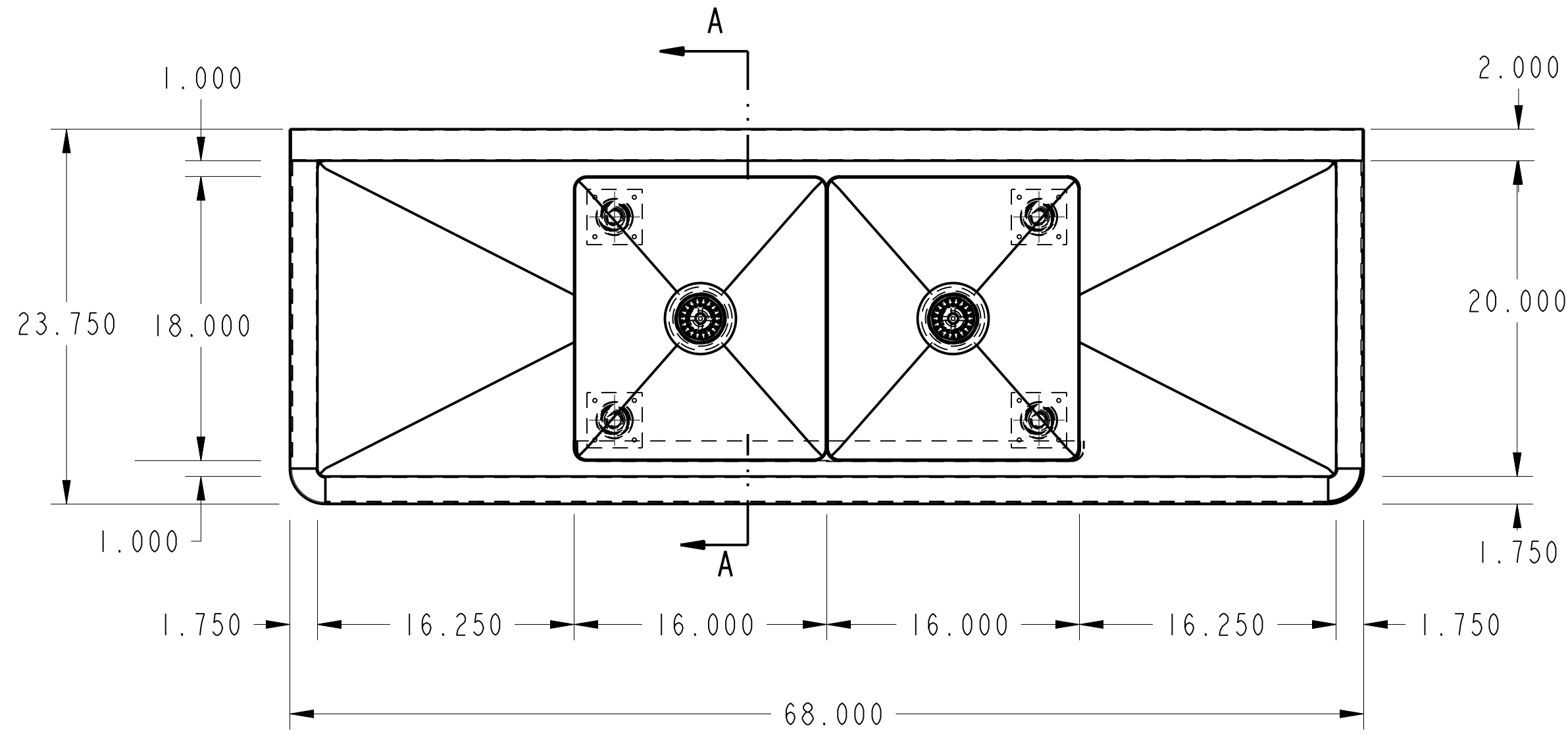

SINKS: 16 GA. STN/STL ALL WELDED CONSTRUCTION. ALL INTERIOR CORNERS TO BE COVERED TO A 3/4" RAD. WITH SPHERICAL INTERSECTIONS. BOTTOM TO BE CREASE TO OPENING FOR LEVER ACTION WASTE AS SHOWN.

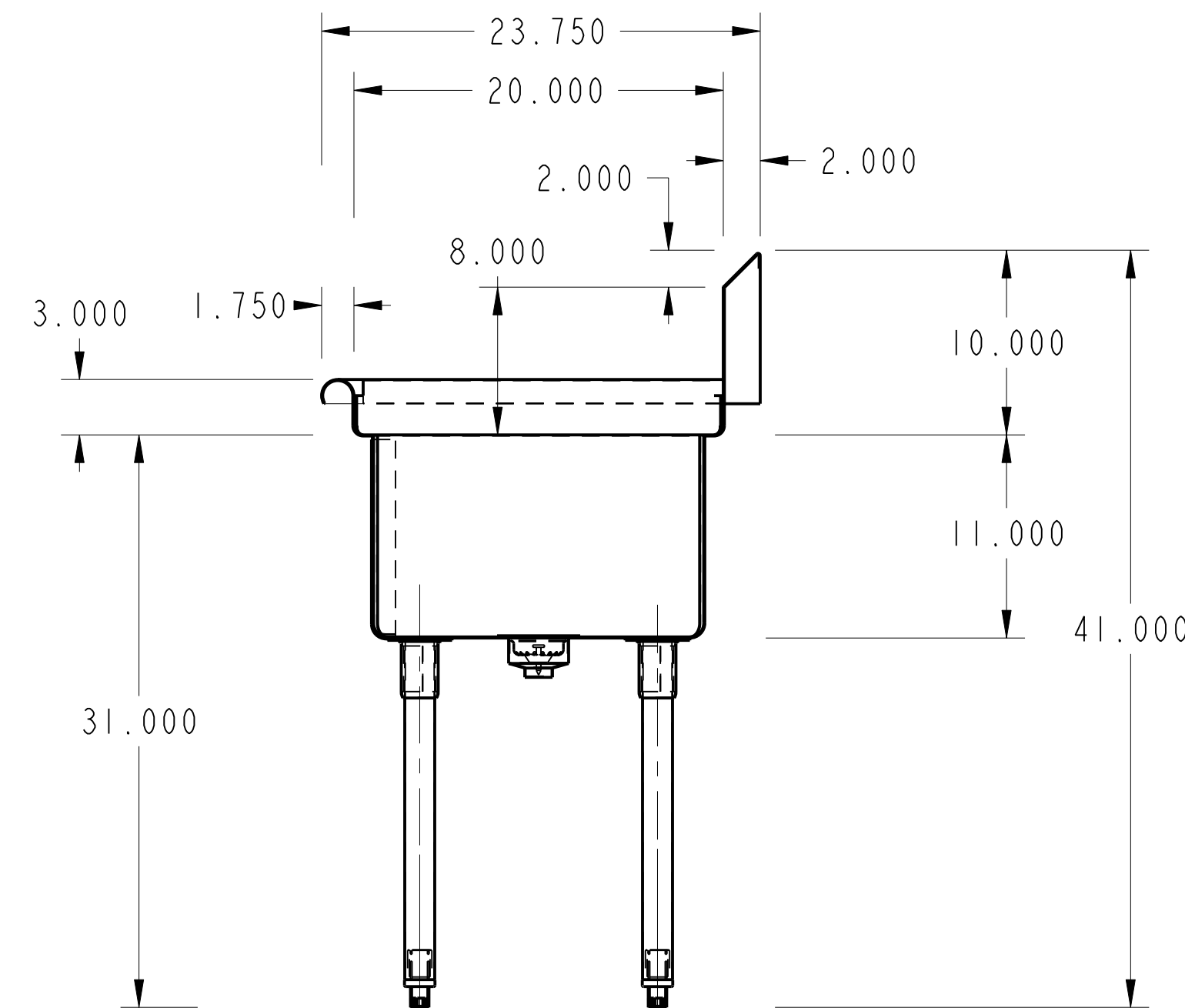
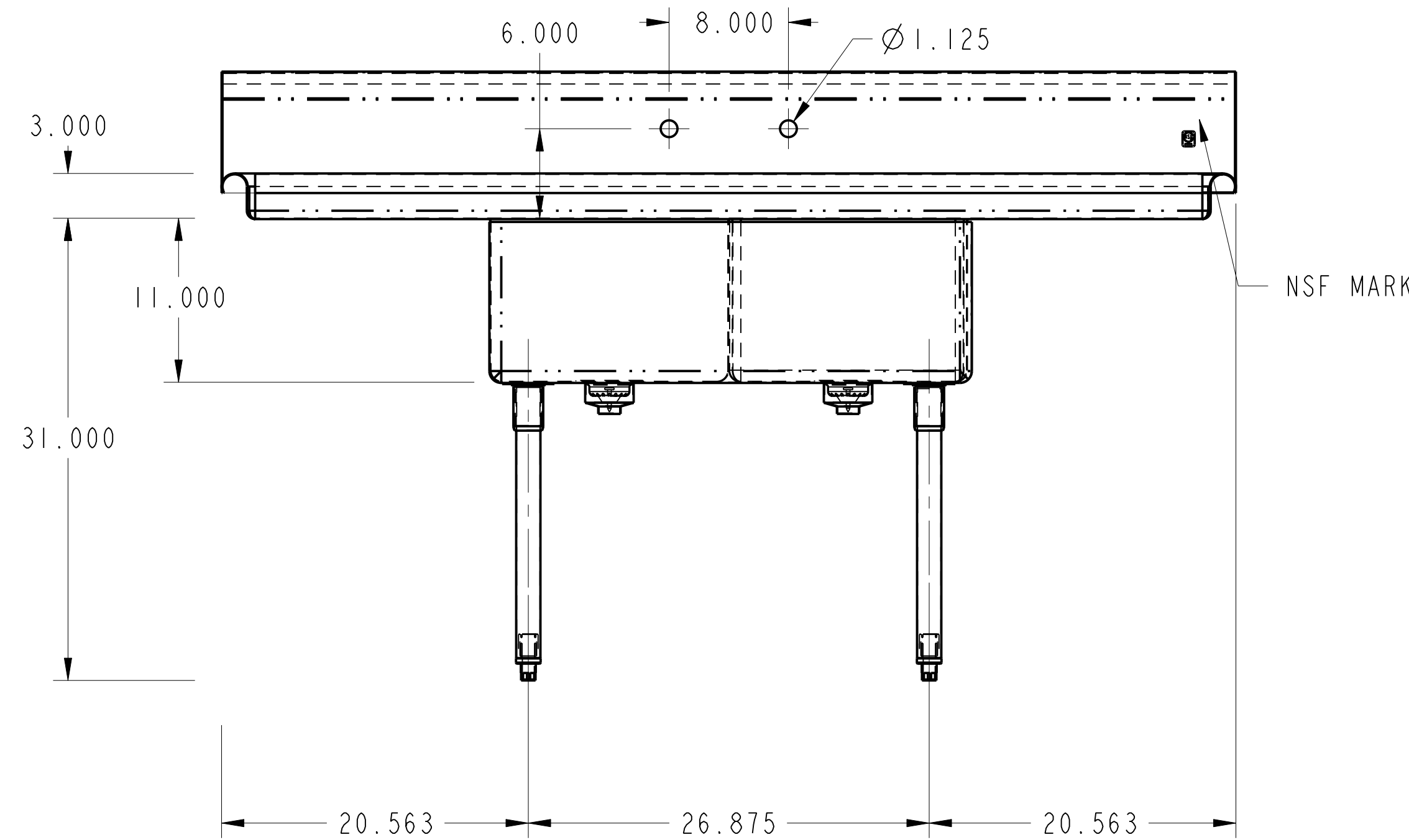
LEGS: 1 5/8" O.D. 16 GA. STN/STL TUBING HELD IN STN/STL LEG HOLDERS WHICH ARE FULLY WELDED TO REINFORCING PLATE ON UNDER SIDE OF SINK BOWLS.

FEET: STN/STL ADJUSTABLE BULLET TYPE.

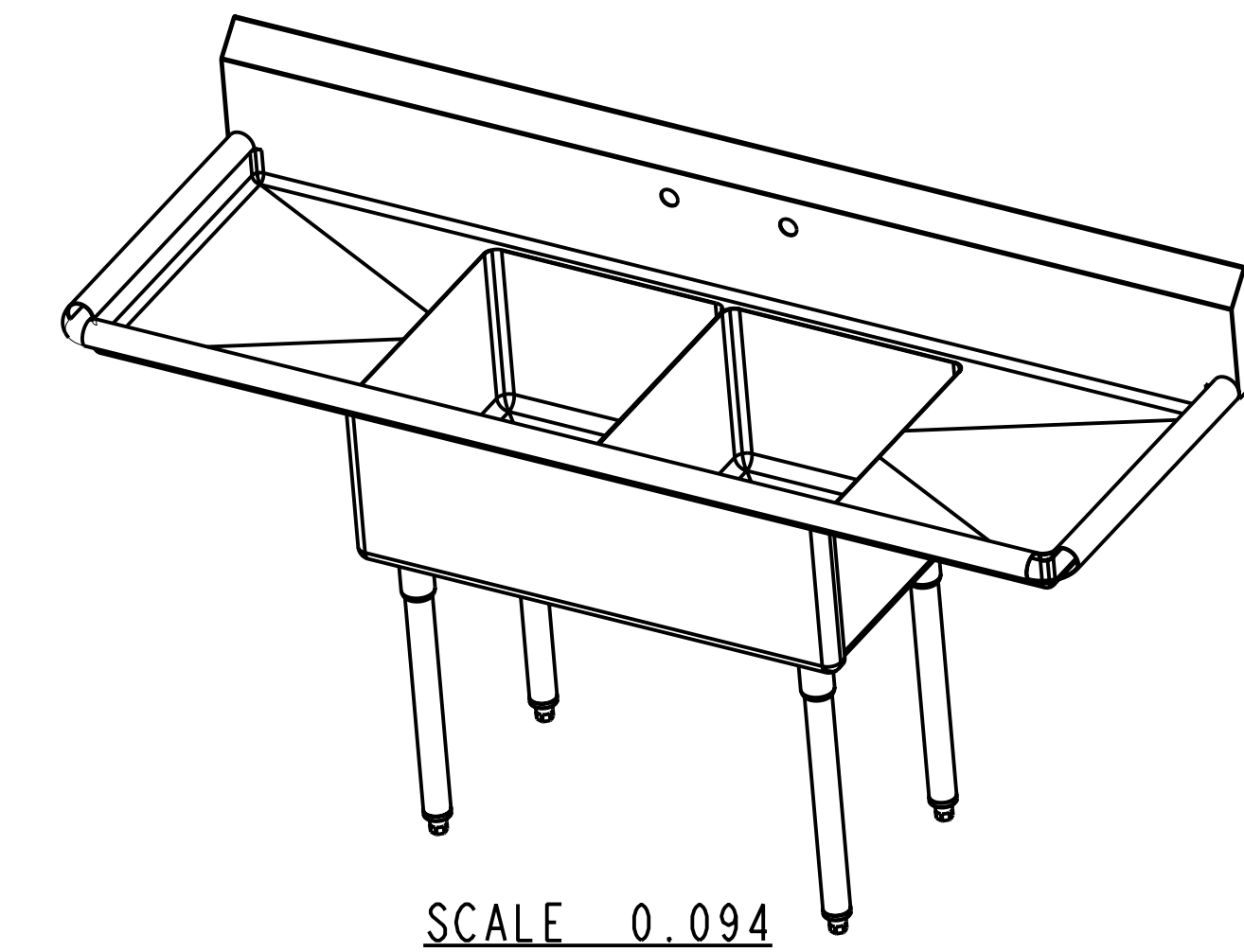
NOTES: ALL STN/STL TO BE TYPE 300 SERIES.
